A Crowd of 250 Attends September's CPNA Meeting

The CPNA meeting of September 10, 2007, featured our School Board representative, Anne Geiger, who earlier had committed to speak to the Neighborhood Association on the subject of College Park schools and their progress. In the days preceding the meeting, however, rumors surfaced that OCPS was considering a plan for Edgewater High School's renovation that included the possibility of using Evans High School as a "swing school".

Under the then rumored plan, EHS students and programs would be relocated to Evans (vacated by 2009) while their College Park campus is razed and rebuilt on its present 29-acre site. While this plan was only one under discussion by staff, the whole process was shrouded by a lack of information. The neighborhood's curiosity was aroused.

A bustle of promotion arose in the community to bring the public to ask questions at the September CPNA meeting. The capacity of the meeting room is limited to 85 persons. Finding that the College Park Community Center gymnasium was already booked, provision was made to televise Ms. Geiger's remarks in the lobby and to carry them over a speaker located outside the building.

That Monday evening, an estimated 250 citizens crowded the meeting room, filled the lobby and looked in at windows. Although there were tense moments, both crowd and speaker maintained their composure, and the program, including a question-and-answer session, proceeded in an orderly fashion. At the end of the evening, Ms. Geiger was awarded polite applause for honoring her commitment to appear. News organizations interviewed several participants.

The meeting highlighted a central theme of CPNA's mission: To provide a platform for the dissemination of information about issues affecting our community.

College Park Neighborhood Association appreciates Ms. Geiger's willingness to speak. While it is her job to respond to residents, she did not have to do so at a CPNA function. Her trust that the Association would provide an appropriate venue is gratifying, and she is welcome, as our representative or as a neighbor, at any time.

Thanks are also due to residents who showed so much interest, provided challenging questions and demonstrated restraint and decorum. The entire stock of membership applications was depleted. Please stay involved -- our community needs you!

Finally, CPNA wishes to express sincere gratitude to the staff of the College Park Community Center, who did everything they could to help the Association conduct a successful meeting. College Park is fortunate in many ways, not the least of which is the spirit of cheerful service shown by these City employees.

Edgewater High School Community Reconstruction Task Force Meeting

The Task Force will hold a community meeting on the future of Edgewater High School. The meeting will be on **Monday, October 1st at 7:00 pm** at the **College Park Baptist Church** in the Fellowship Hall. The College Park Baptist Church is located at 1914 Edgewater Drive.

The meeting will review current information regarding the reconstruction plan, address concerns and answer general questions. A Note on the Status of Edgewater High School Renovation

It has been elsewhere noted that not much new information on the progress of Edgewater high School's renovation plan was presented at CPNA's hugely attended meeting on September 10th at which our School Board representative Anne Geiger spoke.

On the following Thursday, however, OCPS planners made a presentation to COVE, a board that serves as a watchdog for the spending of sales-tax proceeds aimed at school construction. This presentation outlined four possible plans for Edgewater's rebuilding, from one that adds no land and requires the use of Evans High as a "swing school" to one that utilizes both the adjacent shopping center as well as the adjacent trailer park property and requires no moving of students.

Edgewater advocates questioned whether OCPS had done its homework in supplying sufficient facts and figures, particularly concerning hidden costs associated especially with the small-footprint, 29-acre plans. In the end, the COVE members likewise decided they did not have enough of the right data to make a decision. COVE meets again in November, and OCPS has committed to supplying the needed information by the next meeting.

Thus, by press time of this newsletter, no decision had been reached on a plan to reconstruct Edgewater High School either by OCPS or its advisory board. Thank you to Leza Tellam and Mary J. Gray for facilitating the hanging of these two exhibits. Preserving and protecting College Park is one of CPNA's purposes. We have a rich history in College Park and it important to remember our roots.

The theme this year is "Great Additions". College Park is filled with houses that may be considered small by today's standards. Many families have built additions that are compatible with the original architecture and character of their houses. See how these homeowners have provided space for the needs of the 21st century, while preserving the charm of an earlier time.

In addition to the homes that are featured within the theme, the College Park house that Jack Kerouac lived in during his rise to fame will be open to tour participants.

Once again, the Central Florida Plein Air Artists will be painting during the tour. The Central Florida Plein Air Artists are dedicated to preserving and recording, through their paintings, Florida's disappearing natural environments as well as Florida architecture and historic landmarks and sites. To begin the tour, check-in on **November 18th** at the Tour Headquarters at the College Park Community Center between **12:30 and 4:00 pm** where you will be given your tour ticket/brochure. The **College Park Community Center** is located behind Princeton Elementary at 2393 Elizabeth Avenue. The Historic Homes Tour is free for CPNA members. Membership will be available at check-in for College Park residents. For non-members, the admission is \$15 per person and \$10 for seniors.

Information about the houses will be included in your ticket/brochures and through volunteers at each home. Refreshments will be provided at several stops. A portion of the proceeds from this year's tour will be used to fund the Michael Welborn Education Grant. The grant will be awarded to a College Park school for a history-related activity.

CPNA Bylaw Revision

At the October CPNA meeting a vote will be taken on revising CPNA Bylaw Article V Section 1. The Bylaw currently reads:

"The membership of the Board shall consist of the four Officers of the Association and (19) nineteen members of the Board of Directors. Members at Large shall serve for one year or until their successors are elected. Their term of office shall begin on January 1 following the Annual Meeting at which they are elected. There shall be no restriction on the number of terms that a Member at Large may serve. "

The motion is to change the bi-laws to read 16 (sixteen) members of the Board of Directors. CPNA currently operates with 16 Directors. Keeping the number of Director to 16 will make meeting quorums easier to reach.
